

**COMMERCIAL BUILDING EXHIBITOR CONTRACT
NEWTON COUNTY FAIR ASSOCIATION**

It is hereby mutually agreed that the Newton County Fair Associations and _____
_____ have agreed to a contract granting said exhibitor the privilege of displaying and
advertising at the 2009 Newton County Fair. Said exhibitor agrees to pay the sum of \$ _____.
For the privilege of utilizing the space in the Commercial Building identified as Space _____. This
space will include _____ 6 foot tables for exhibitors use.

1. The exhibitor agrees that the display will be in place for public viewing no later than 4:00 PM on Monday July 19 2009 and shall remain in place through 10:00 pm Saturday July 25, 2009. The Commercial Building will be open to the public from 5:00 - 10:00 pm nightly, Monday through Saturday. Displays are to be removed no later than 12:00 noon on Sunday.
2. Each exhibit space shall be identified with the name of the business or organization prominently displayed.
3. The exhibitor must confine his/her exhibit and activity to the space described above. No advertising, canvassing or solicitation is permitted on other portions of the fair grounds.
4. No automobiles, trucks, or trailers will be permitted to park on contracted space unless said vehicle is an integral part of the display itself.
5. No food or drink is to be sold in any contracted space in the commercial building. Food or drink that is given away or served will be subject to board approval.
6. It is mutually agreed that this agreement shall be binding upon the heirs and assigns of the parties hereto and that no contracted space may be sublet without the expressed permission of the fair association.
7. Any violation of terms of this contract will result in forfeiture of any and all rights granted the exhibitor and an interest in monies previously paid on this contract.
8. Each exhibitor shall provide the Newton County Fair Association with a certificate of insurance before setting up exhibit. .
9. A \$25.00 deposit will be refunded to exhibitor after clean up as long as exhibitor did not leave prior to end of fair and booth was removed promptly at the end of the fair.

IT IS MUTUALLY AGREED THAT THE NEWTON COUNTY FAIR ASSOCIATION SHALL NOT BE HELD LIABLE FOR ANY LOSS SUSTAINED BY THE EXHIBITOR IN ANY MANNER WHATSOEVER DURING THE PERIOD OF TIME HIS/HER EXHIBIT IS ON THE NEWTON COUNTY FAIRGROUNDS. IT IS FURTHER MUTUALLY AGREED THAT THE CONDITION ENUMERATED ABOVE ARE MADE A PART OF THIS CONTRACT.
